NOTE: The obedience trial and rally trials are separate trials. If you enter both, you must pay the fees appropriate for each individual trial. Entry form must include the Agreement section and must be signed at the bottom by the owner or authorized agent; otherwise the entry cannot be accepted.

NOTICE TO EXHIBITORS — PLEASE READ

- Make checks or money orders payable to GCA. No credit cards accepted.
- NOTICE TO UDX or RAE Class Entrants: those wishing to enter these classes only if their entries are accepted for BOTH Open B/Utility B for obedience or BOTH Advanced B/Excellent B for rally should write a note on the entry form.
- Telegraph, Telephone, FAX, E-mailed and Unsigned Entries Cannot Be Accepted. Entries Not On Official AKC Entry Forms and Photocopies of Entry Forms without the Agreement and Rules of the Official AKC Entry Form are NOT ACCEPTABLE.
- Recording fees will be required for each dog entered at any licensed or Member Club show, Obedience Trial, Rally Trial, or Tracking Test. This fee is collected by the show-giving club and paid to the American Kennel Club.
- There will be an AKC Service Fee of \$3.00 and an AKC recording fee of \$0.50 per entry in the Obedience Trial. There will be an AKC Recording Fee of \$3.00 per entry in the Rally Trial. If a dog is entered in more than one class, the fee is collected on all classes the dog is entered in. These fees are already included in the entry fee listed.
- Entries Cannot Be Accepted, Canceled, Altered or Substituted after the entries have closed. (See exceptions for Move-ups and for bitches in season.)
- Bitches in season are eligible for a return of the entry fee (minus a \$5 fee per bitch). Proof of the bitch being in season may be made by a statement from a veterinarian. This may be sent to the Trial Secretary or brought to the trial.
- No entry will be accepted which carries any conditions regarding its acceptance.
- Declination of Entries. The Greyhound Club of America may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other cause and no one shall have any claim or recourse against the Greyhound Club of America or any official thereof.
- Errors on Entry Blanks. Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.
- Returned Checks do not constitute a valid entry fee. The TRIAL SECRETARY will add a collection fee to the amount of each returned check.
- Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge or barred from competition by action of Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the Greyhound Club of America, it is impossible to open or to complete the trial, no refund or entry fee will be made. The Greyhound Club of America will not be responsible for loss or damage to property while on the trial site.
- Judges Are Not Required to Wait for Dogs. The owner or handler of each dog is solely responsible for having it ready at ringside when its class is to be judged.
- Vehicles parked contrary to regulations will be subject to towing at owner's expense.
- All Handlers Must Pick Up After Their Dogs. Anyone witnessed not cleaning up after their dogs will be requested to leave and no refunds given.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, and any communicable diseases, and have appropriate vaccinations.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or lessor of the premises and any employees of the aforementioned parties, and any AKC judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury, or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property arising out of or in consequence of my (our) participation in this event, however such injuries, death or damage to property may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents, or any other persons.
